

## **OUTREACH CALLS**

<u>Instructions</u>: Follow script to assist with outreach calls (feel free to adjust to fit your style). It's usually best to practice a few times just to get the feel of the conversation and message you're conveying. If you don't follow the script exactly—the main points to touch on are:

- Who you are
- Where you're calling from
- What ABF does (helping girls pursue their dreams!)
- Why you're calling (to tell them about our grant programs and the next deadline)
- What you want them to do (refer girls!)
- Application deadline (Fall—October 1 and Spring—April 1)

## **CALL SCRIPTS**

## If they answer the phone:

"Hello! My name is\_\_\_\_\_ from the Outreach Committee for the Ann Bancroft Foundation. I am contacting you today to let you know about our grants for girls programs. We have a grant application deadline coming up [April 1st or October 1st] and are looking for your help to spread the word know about the availability of our grants.

"At Ann Bancroft Foundation, we award grants up to \$500 to Minnesota girls in grades K-12 to participate in experiences that encourage them to imagine something bigger. We often fund an experience for a girl to attend a camp, class, or assist with fees and equipment for participation in athletics. The grants we fund are as diverse as the dreams our girls have. With the help of a mentor, the girl has the opportunity to have someone listen and encourage her and she learns how to advocate for herself."

A few follow-up questions:

- "Do you know any girls at your school that would benefit from our grants?"
- "Would you help us spread the word at your school?"
- "Can I send you a link to our website or send you a copy of the guidelines and application?"
